## 2023 ANNUAL REPORT

Divide MPC Metropolitan District No. 1 hereinafter referred to as "District", Teller County, Colorado, is a quasimunicipal corporation and political subdivision of the State of Colorado.

#### **OVERVIEW**

The District strives to fulfill its goals, objectives, and activities through the following means:

- Provide certain essential public-purpose facilities for the use and benefit of the anticipated residents and property owners within the District and for the Development as currently planned.
- District is the Service District organized to finance, construct, own, manage and operate the public improvements throughout the Development. The District originally consisted of approximately 37 acres of land, by Order of Exclusion reduced to 2 acres of land in 2014.
- Pursuant to the Service Plan approved August 23, 2001, the District is empowered to provide street, water, sanitation collection system, park and recreation, safety protection, transportation, mosquito control, television relay and transmission, and perpetual maintenance and other improvements and services within its service area.

The District is in its twenty-second (22<sup>nd</sup>) year of operation. Since November 2001, the District has been actively involved in planning the timely development of needed infrastructure for its residents and property owners. #### GOALS AND OBJECTIVES

The District does not anticipate Bond Issuance in 2024.

#### **BUDGET AND FINANCE**

The District is proposing three (3) separate 2024 funds:

General Fund. The General Fund will provide for general operating expenses. Revenues will be generated from payment from Divide MPC Metropolitan District No. 2, for contracted services. Expenditures include administrative services based upon contracted amounts, lease agreements, Easement / Access Agreement, legal services and expenses related to the statutory operations of a local government. The District has provided for the Emergency Reserve Fund in the amount of 3% of the total fiscal year spending in the General Fund in accordance with Article X, Section 20 of the Colorado Constitution.

<u>Capital Project Fund</u>. The Capital Project revenues are mainly generated from Water Tap Fees, new loan, and Teller County Project Funding. Expenditures include Water Facility, Safety and Street Improvements, Water Lease interest, Developer Advance interest and or principal payments for 2024.

<u>Water Facility Enterprise Fund</u>. The Water Facility Enterprise Fund revenues are mainly generated from water tap fees, system operation charges, and water usage fees and AOS charges. Expenditures include System Operations, Easement / Access Agreement and Water Rights Lease Agreement.
